

## 26 YEARS IN CHILD PASSENGER SAFETY

A longtime advocate of Child Passenger Safety, Joe started his activities as a direct result of a personal family tragedy. His niece was tragically killed in a crash that was later determined was because of child seat and vehicle incompatibility. His advocacy over the years has reached thousands of families and Child Passenger Safety techs and Instructors nationwide, and his media work has reached millions. Joe remains a featured presenter at local and national conferences with a nationwide network of highway safety professionals. Colella's outreach has



been extensive, and influences have changed attitudes and been a catalyst for improvements in regulation and legislation on a national and state level.

- Develops and delivers accredited training courses for state agencies, private companies, children, parents, grandparents, healthcare providers, law enforcement officers, first responders, childcare providers, judges, attorneys, educators, child protective services employees, drivers and others
- Produces culturally sensitive messaging for underserved but statistically overrepresented segments
- Strategizes with international and government organization leaders on improving effectiveness
- Facilitates skills development opportunities for instructors, technicians, public servants and others
- Author of articles for industry publications, individual manufacturers and advocate organizations
